

COVID-19 DIRECTIVE REGULATING THE OBLIGATIONS OF PERSONS ENTERING THE PREMISES OF THE ROCKNET ARENA

The Czech Ice Hockey Association (*Czech: Český svaz ledního hokeje z.s.*), with its registered office at Českomoravská 2420/15, Libeň, Prague 9, Post Code 190 00, Identification No.: 00536440, and PRO - HOCKEY Cz., s.r.o., with its registered office at Českomoravská 2420/15, Libeň, Prague 9, Post Code 190 00, Identification No.: 25062689, as the organizer of the 2022 final Olympic qualification tournament in women's ice hockey at the ROCKNET Arena in Chomutov, in the context of the prevention of the spread of Covid-19, sets out the following conditions for the participation of visitors in this sporting event (hereinafter the "Event") on the premises of the ROCKNET Arena.

Only those who prove to the organizer that they meet the conditions set forth in Article I/16 of the Extraordinary Measure of the Ministry of Health Ref. No. MZDR 14601/2021-25/MIN/KAN, adopted on 27 September 2021 and effective from 30 September 2021, may participate in the Event at the ROCKNET Arena (i.e. those who submit a certificate of a negative RT-PCR test not older than 7 days; a negative POC test not older than 72 hours; a national certificate of completed vaccination, provided that at least 14 days have elapsed since the last dose; a proof of recovery from a laboratory-confirmed Covid-19 disease, provided that the isolation period has elapsed and no more than 180 days have elapsed since the first positive test). Should a visitor refuse to prove compliance with these conditions, they will not be admitted to the Event and will not be entitled to an entrance fee refund.

In addition, every visitor entering the premises of the ROCKNET Arena and throughout their stay on the premises of the ROCKNET Arena:

- is **prohibited from entry if they show clinical symptoms of covid-19 disease** (especially a high temperature or a cough) or if they have come into contact with a person who has shown such disease symptoms – **IF YOU ARE NOT HEALTHY, DON'T GO TO HOCKEY GAMES AND STAY AT HOME**
- may enter and stay there **only with a breathing mask or a similar device (without an exhalation valve and with a filtration efficiency of at least 94% such as an FFP2 or a KN95 mask; for children below 15 years of age it is possible to use a medical face mask)** – this shall not apply especially to children below 6 years of age
- must **disinfect their hands** upon entering the premises and then after any contamination
- must follow the instructions and signage system of the organizer **and sit only in their reserved seat or stand only in the sector** indicated on their purchased ticket
- must **keep their distance as much as possible** except for those from the same household and must **limit contact with other people.**

The organizer or the organizing or security staff may carry out a check of the medical condition of any visitor entering the premises of the ROCKNET Arena (visually and by measuring the visitor's temperature) and may prohibit the visitor from entering the arena if they have doubts about the visitor's medical condition, especially if the visitor's measured temperature is 37°C or higher.

At the same time, everyone who has entered the premises of the ROCKNET Arena agrees to observe the visitor rules of the Event. If these rules are not observed, the operator or the organizing or security staff may take appropriate sanctioning measures in accordance with the visitor rules.

In the event of a breach of any of the above rules, the visitor may be subject to criminal prosecution by the competent law enforcement authorities on the suspicion of having committed the crime of spreading a contagious human disease according to Section 152 or Section 153 of the Criminal Code.
